ARTICLES OF INCORPORATION

incorporators for the purpose of creating a non-profit corporation under the laws of the State of North Carolina, as contained in Chapter 55A of the General Statutes of North Carolina, entitled "Non-Profit Corporation Act", and the several amendments thereto, do hereby set forth:
1. The name of the corporation is The North Central Piedmont Resoure Conservation &
Development Area, Inc.
2. The period of duration of the corporation shall be Perpetual
(May be perpetual or for a limited period)
3. The purposes for which the corporation is organized are: To plan and promote the orderly conservation, development, discovery, and utilization of natural resources including, but not limited to, the following: (1) Water (2) Land (3) Human, (4) Cultural (5) Forestry (6) Recreation and (7) Wildlife; to improve the general level of economic activity; enhance the environment; and improve the standard of living. This corporation is organized exclusive for education, benevolent and public purposes within the meaning of Section 501 (a) (3) of the Internal Revenue Code of 1954.
4. The corporation is to have the following class or classes of members: (If there are to be
no members, so state.) There shall be twenty-one (21) members composed of three (3) members from each of the following counties in the State of North Carolina: Alamance, Caswell, Chatham, Guilford, Orange, Randolph and Rockingham. Said members to be appointed as provided by the by-laws.
